- 2/ Customers taking transportation service will pay the Basic Service Charge, the Commodity Charge per Therm less the Monthly Gas Cost, and Demand Charge, if applicable, of the Currently Effective Tariff Rate for each meter included in the transportation service agreement, plus amounts of \$0.00197 per therm for distribution shrinkage as defined in Rule No. 1 of this Arizona Gas Tariff and \$0.00020 per therm to recover the cost of any incremental upstream pipeline charges or penalties incurred by the Utility. The shrinkage charge and upstream pipeline charge shall be updated annually effective May 1. For customers converting from sales service, an additional amount equal to the currently effective Gas Cost Balancing Account Adjustment will be assessed for a period of 12 months.
- 3/ Effective March 27, 2025, the Regulatory Expense Surcharge will collect the rate case expense of \$475,102, which includes the expense incurred in the 2024 Arizona General Rate Case (GRC) and the remaining balance from the 2021 GRC. The balance will be recovered over a 36-month period. It applies to all Arizona customers except G-30, G-65, and special contract customers. The surcharge will be assessed on a volumetric basis and will be included as part of the rate adjustment in Footnote 4.
